Rules and Information:

- The racing box may be constructed with only cardboard, paint, tape, glue, rope or twine, and plastic zip-ties.
- The sliding surface of the racing box must be **either** uncoated cardboard or cardboard covered with tape. No other substance may be on the sliding surface.
- Decorations are encouraged but must not pose a hazard to participants or spectators.
- For safety, pre-existing metal staples in cardboard must be removed.
- Following the race - all boxes and extraneous materials must be removed from the premises! \$100 assessed to team contact for abandoned boxes or debris.
- Box entries will be inspected during registration. Decisions of the judges are final. Each box must display an "inspected" sticker.
- Each team must wear its assigned bib while racing.
- Participants must be able to push or pull their box to the top of the track.
- Helmets are required; rental helmets are available for \$5.
- All racers must SIGN INDIVIDUAL WAIVERS to be allowed to race!

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If however I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE TOWN OF CAMDEN, THE CAMDEN SNOW BOWL, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of the premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
